SUBORDINATION OF MORTGAGE

THIS SUBORDINATION OF MORTGAGE executed this 11th day of August, 2003 by SouthTrust Bank.

W I T N E S S E T H:

WHEREAS, Tim A. Pekarek and Andrea M. Pekarek ("Pekareks") are the owners of the real estate particularly described as follows:

Lot 33, according to the Survey of Southpointe First Sector, as recorded in Map Book 11, page 83, in the Probate Office of Shelby County, Alabama.

WHEREAS, Pekareks heretofore executed a mortgage in favor of SouthTrust Bank, recorded as Instrument #1998-50881, in the Probate Office of Shelby County, Alabama; and

WHEREAS, Pekareks now desire to obtain a mortgage loan from Synovus Mortgage Corporation, in the principal amount of \$129,000.00 and

NOW, THEREFORE, for and in consideration of the premises and of Ten and No/100 Dollars (\$10.00) and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned does hereby covenants, stipulates, warrants and agrees as follows:

1. SouthTrust Bank hereby subordinates all its rights, title and interest in and to the lien created by the SouthTrust Bank mortgage to the lien created by the Synovus Mortgage Corporation mortgage and other loan documents as defined in the mortgage in favor of Synovus Mortgage Corporation, its successors and assigns.

2. SouthTrust Bank hereby warrants and represents that it is the owner of the SouthTrust Bank mortgage and that the SouthTrust Bank note which secures the SouthTrust Bank mortgage has not been prior pledged, encumbered or mortgaged by SouthTrust Bank.
