

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 5, 2001, Mark R. Moore and Theresa L. Moore, husband and wife as Joint Tenants, Party of the First Part, executed a certain mortgage to Long Beach Mortgage Company, which said mortgage is recorded in Real Property Book 2001, Page 44511, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Wachovia Bank, NA (fka First Union National Bank), as Trustee for Long Beach Mortgage Loan Trust 2001-4; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Wachovia Bank, NA (fka First Union National Bank), as Trustee for Long Beach Mortgage Loan Trust 2001-4 in the amount of ONE HUNDRED NINETY-FIVE THOUSAND SIXTY-THREE AND 54/100 DOLLARS (\$ 195,063.54); which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to Wachovia Bank, NA (fka First Union National Bank), as Trustee for Long Beach Mortgage Loan Trust 2001-4; and
