Both mortgages pertain to certain real property described as follows:

Commence at the Southwest corner of the Southeast 14 of the Southeast 14 of Section 16, Township 19 South, Range 2 West, Shelby County, Alabama; thence run East along the South line of said Section 16 a distance of 531.50 feet; thence turn left 90 degrees 01 minutes 24 seconds and run North a distance of 325.0 feet to the Point of Peginning; thence continue along the last described course a distance of 106.22 feet; thence turn right 83 degrees 38 minutes 26 seconds and run Easterly a distance of 119.71 feet; thence turn left 38 degrees (14 minutes 37 seconds and run Northeasterly a distance of 78.68 feet; thence turn right 134 degrees 26 minutes 11 seconds and run South a distance of 135.25 feet to the Northwesterly right-ofway line of County Road #369; thence turn right 39 degrees 56 minutes 18 seconds and run Southwesterly along said right-of-way line a distance of \$1.83 feet; thence turn right 50 degrees 05 minutes 06 seconds and run West a distance of 141.73 feet to the Point of the Beginning.
