KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Five Hundred Eighty-Five Thousand Nine Hundred and no/100 Dollars (\$585,900.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, RUDY R. JAMES, A SINGLE MAN and LINDA G. JAMES, A SINGLE WOMAN, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto, PATRICIA W. YOST and JOSEPH C. YOST, (herein referred to as "Grantees"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 43, according to the Survey of Greystone, 1st Sector, Phase I, as recorded in Map Book 14, Page 91 A & B, in the Probate Office of Shelby County, Alabama

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2003 and subsequent years not yet due and payable.


\$300,000.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.

AND THE GRANTOR does for their heirs and executors, successors and assigns, covenant with said Grantees, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and their heirs and executors, successors and assigns shall warrant and defend same to said Grantees, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.

IN WITNESS WHEREOF, the Grantor has signed and sealed this Deed on the 18th day of August, 2003.


