## DOMESTIC LIMITED LIABILITY COMPANY ARTICLES OF ORGANIZATION GUIDELINES

# **ARTICLES OF ORGANIZATION OF THE HOME TEAM, LLC**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the “Alabama Limited Liability Company Act”), files the following Articles of Organization with the probate office of the county in which the initial registered office of the limited liability company will be located and affirms that the facts stated herein are true and correct.

## **ARTICLE ONE**

### **NAME**

The name of the limited liability company is **THE HOME TEAM, LLC. (THE “COMPANY”)**.

## **ARTICLE TWO**

### **DURATION**

The term of the Company shall be perpetual from the date of the filing of these Articles of Organization with the probate office of the county in which the initial registered office of the Company is located, unless the Company is earlier dissolved in accordance with the operating agreement of the Company or the Alabama Limited Liability Company Act.

## **ARTICLE THREE**

### **PURPOSE**

The purpose or purposes for which the Company is organized is for the transaction of any or all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act.

## **ARTICLE FOUR**
