

QUITCLAIM DEED

THIS QUITCLAIM DEED, executed this 31 day of July, ²⁰⁰³ by first party, Grantor, Dorothy Brechin and David Brechin, whose post office address is 55 Brechin Lane / Columbiana, Alabama, 35051 to second party, Grantee, John A. WITNESSETH, That the said first party, does hereby remise, release and quitclaim unto the said second party forever, all the right, title, interest and claim which the said first party has in and to the following described parcel of land, and improvements and appurtenances thereto in the County of Shelby, State of Alabama to wit:

Commence at the northwest corner of said Northwest Quarter of the Southwest Quarter: thence N 90°00'00" E a distance of 56.00 feet to the intersection of the north line of said Northwest Quarter of the Southeast Quarter and the easterly right-of-way line of Shelby County Highway 49; thence S 00°00'00" E along said easterly right-of-way line a distance of 390.80 feet to a grader blade found at the southwest corner of a 1 acre parcel of land as described in Deed Book 306, Page 75, in the Office of the Judge of Probate for said Shelby County and the Point of Beginning: thence N 90°00'00" E a distance of 210.86 feet to a grader blade found at the southeast corner of said 1 acre parcel: thence S 08°16'26" W a distance of 234.30 feet to a 1/2" rebar set; thence N 86°33'43" W a distance of 177.10 feet to a 1/2" rebar set on said easterly right-of-way line; thence 00°05'36" W a distance of 221.24 feet the Point of Beginning.
