That in consideration of ONE HUNDRED EIGHTY NINE THOUSAND FIVE HUNDRED AND NO/100'S (\$189,500.00) DOLLARS to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, RICK J. AUSTIN AND CAROL A. AUSTIN, HUSBAND AND WIFE (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto MARK G. RUSSELL AND JEAN S. RUSSELL (herein referred to as GRANTEES, whether one or more), as joint tenants with right of survivorship, the following described real estate, situated in SHELBY County, Alabama to-wit:



The preparer of this instrument has served as a scrivener only and has not examined title to the property for purposes of Grantors's representations made herein or rendered any opinion with respect thereto.
