COVENANT

WHEREAS, MITCHELL RAY MANSFIELD and CHRISTINE W. MANSFIELD, spouse, hereinafter called the "Owners" of a certain parcel of real property situated in Shelby County, Alabama, more particularly described as follows:

**246-B BENT RIVER COMMONS THIRD SECTOR FIRST ADDITION as
recorded in Map Book 30, page 31, in the office of the Judge of Probate of
Shelby County, Alabama;**

attached hereto and incorporated fully, herein called the "Property"; and,

WHEREAS, upon said Property the Owners desires to construct an alternative onsite sewage disposal system designed to serve the above described Property, hereinafter called the "Onsite System", to service the facility, facilities, dwelling or dwellings, as the case may be, on said Property; and,

WHEREAS, the Owners desire that the Onsite System be connected to and become a part of a common sewer system serving the Property and other parcels of real property in the vicinity, herein referred to as the "Cluster System"; and,

WHEREAS, the ownership and maintenance responsibility of the Cluster System shall vest exclusively in Community Environmental Systems, Inc. herein called the "Utility"; and,

WHEREAS, upon completion and acceptance by the Utility and the appropriate Governmental Authorities including the Shelby County Health Department, title to the Onsite System shall be vested in the Utility and the Onsite System shall become a component of the Cluster System

WHEREAS, the approval of the Onsite and Cluster Systems by the Shelby County Health Department, hereinafter called the local health department, is conditioned upon the covenant by the owners of the System and the owners of each of the parcel's of Property and its successors in title and its assigns that it will satisfy all of the requirements of the local health department and assure the proper functioning of the system.

NOW, THEREFORE:

"Public notice is hereby given that the Property described herein is subject to an on-site sewage disposal permit issued by the Shelby County Health Department. The permit may restrict the use of the Owner's lot or obligate the Owners of the Lots and the Utility to special maintenance and reporting requirements and the permit may restrict the Utility to special maintenance and reporting requirements and penalties. These conditions are on file with the Shelby County Health Department, and subsequent purchasers are directed to inquire at the Shelby County Health Department."




