FIFTH AMENDMENT TO THE CREST AT GREYSTONE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS FIFTH AMENDMENT to The Crest at Greystone Declaration of Covenants, Conditions and Restrictions is made and entered into as of the 3rd day of September, 2003 by DANIEL OAK MOUNTAIN LIMITED PARTNERSHIP, an Alabama limited partnership ("Developer").

RECITALS:

Developer has heretofore executed The Crest at Greystone Declaration of Covenants, Conditions and Restrictions dated October 2, 1992 which has been recorded as Instrument No. 1992-22103 in the Office of the Judge of Probate of Shelby County, Alabama, which has been amended by (i) First Amendment thereto dated February 3, 1994 and recorded as Instrument No. 1994-03752 in said Probate Office, (ii) Second Amendment thereto dated January 10, 1995 and recorded as Instrument No. 1995-00941 in said Probate Office, (iii) Third Amendment thereto dated October 25, 1995 and recorded as Instrument No. 1995-32703 in said Probate Office and (iv) Fourth Amendment thereto dated August 22, 2001 and recorded as Instrument No. 2001-38397 (collectively, the "Declaration"). Capitalized terms not otherwise expressly defined herein shall have the meanings given to them in the Declaration.

Developer desires to (i) submit Additional Property to the terms and provisions of the Declaration, as provided in Section 2.02 of the Declaration, all of which shall constitute common areas as defined in the Declaration, and (ii) add additional provisions to Section 6.22.

NOW, THEREFORE, in consideration of the premises, Developer does hereby amend the Declaration as follows:

1. <u>Additional Property</u>. Pursuant to the terms and provisions of Section 2.02 of the Declaration, Developer does hereby declare that the real property described in <u>Exhibit A-3</u> attached hereto and incorporated herein by reference (the "<u>Additional Property</u>") shall be held, developed, improved, transferred, sold, conveyed, leased, occupied and used subject to all of the easements, covenants, conditions, restrictions, charges and regulations set forth in the Declaration, which shall be binding upon and inure to the benefit of all parties acquiring or having any right, title or interest in any portion of the Additional Property and their respective heirs, executors, administrators, personal representatives, successors and assigns. The Additional Property described in <u>Exhibit A-3</u> attached hereto, the original Property described in the Declaration and all Additional Property heretofore submitted by Developer to the terms and provisions of the Declaration shall, for the purposes of the Declaration, collectively be referred to as the Property and all references in the Declaration to the Property shall mean the original Property as described in the Declaration, all Additional Property heretofore submitted to the terms and provisions of the Declaration as well as the Additional Property described herein. of the Additional Property described in Exhibit A-3 hereto shall constitute and be deemed to be the Common Areas, as defined in the Declaration.

2. Pets and Animals. The Declaration is amended by adding the following at the end of Section 6.22:

"Notwithstanding anything provided herein to the contrary, to the extent any Owner or Occupant violates any of the laws, statutes, ordinances, rules or regulations of the City of Hoover, Alabama with respect to any pets or other animals maintained by such Owner or Occupant on or within any Lot or Dwelling or within any portion of the Development, then enforcement of such laws, statutes, ordinances, rules and regulations shall be solely by the City of Hoover, Alabama and not the Association."

3. <u>Full Force and Effect</u>. Except as specifically modified and amended herein, all of the terms and conditions of the Declaration, as previously amended, shall remain in full force and effect.

a distance of 152.48 feet to a point; thence run South 30 degrees, 17 minutes, 42 seconds West for a distance of 159.70 feet to a point; thence run South 65 degrees, 08 minutes, 51 seconds West along said Northwest right-of-way line for a distance of 35.00 feet to a point; thence run South 04 degrees, 33 minutes, 27 seconds East along said Northwest right-of-way line for a distance of 35.00 feet to a point; thence run South 31 degrees, 07 minutes, 07 seconds West for a distance of 39.80 feet to a point on a curve to the right having a central angle of 166 degrees, 22 minutes, 28 seconds and a radius of 5.00 feet; thence run in a Southwesterly to Northwesterly direction along the arc of said curve for a distance of 14.52 feet to a point on the Southeast right-of-way line of Hugh Daniel Drive; thence run North 16 degrees, 40 minutes, 10 seconds East for a distance of 75.89 feet to a point on a curve to the right having a central angle of 10 degrees, 20 minutes, 33 seconds and a radius of 950.00 feet; thence run in a North easterly direction along the arc of said curve and also along said Southeast right-of-way line for a distance of 171.49 feet to a point; thence run North 27 degrees, 00 minutes, 43 seconds East for a distance of 193.23 feet to a point on a curve to the left having a central angle of 160 degrees, 19 minutes, 19 seconds and a radius of 156.66 feet; thence run in a Northwesterly to Southwesterly direction along the arc of said curve and also along said Southeast right-of-way line for a distance of 438.36 feet to an iron pin found; thence turn an angle from the chord of last stated curve to the right of 88 degrees, 57 minutes, 56 seconds and run North 35 degrees, 50 minutes, 45 seconds East for a distance of 815.48 feet to the point of beginning; said parcel containing 4.910 acres, more or less.

"Greystone Crest", as described and shown on the Amended Map of The Crest at Greystone as recorded in Map Book 18, Pages 17 A, B, C and D in the Office of the Judge of Probate of Shelby County, Alabama.
