

**ARTICLES OF INCORPORATION  
OF

A BODY CORPORATE**

**TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:**

The undersigned, Jerod C. Ryals, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation shall be **HTE, INC.**, and the corporation shall be authorized to operate under said name or use any other trade name not now being used by another person, firm or corporation.

2. The purposes for which the corporation is formed are as follows:

- a. To engage in the business of selling, installing and servicing video, audio, entertainment, phone and security systems.
- b. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.

3. The location of the initial registered office of the corporation shall be 324 Waterford Cove Trail, Calera, Alabama 35040, and the name of its initial registered agent at such address is Jerod C. Ryals.

4. The authorized capital stock of the corporation shall be One Thousand (1000) shares of capital stock at a par value of One Dollar (\$1) per share. The paid-in capital with which the corporation shall begin business shall be One Thousand Dollars (\$1,000).
