PREMISES

That certain lease dated October 1, 1982 by and between Columbiana Properties, Ltd. ("Lessor") and Tacala, Inc. ("Lessee") concerning the following described property:

Commence at the Southwest corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 26, Township 21 South, Range 1 West; thence run North along the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 215.31 feet to the South R/W line of Alabama Highway No. 70; thence turn an angle of 89 deg. 05 min. 33 sec. to the right and run along said R/W a distance of 153.90 feet to the P.C. of a R/W curve; thence continue along said R/W curve (whose Delta Angle is 14 deg. 06 min. 08 sec. to the right, Radius is 1931.32 feet, Tangent is 238.88 feet, Length of Arc is 475.35 feet) to a point on said R/W curve, and the point of beginning; thence turn an angle of 88 deg. 59 min. 54 sec. to the right, from tangent of said curve, and run a distance of 210.00 feet; thence turn an angle of 85 deg. 52 min. 54 sec. to the left and run a distance of 210.00 feet; thence turn an angle of 94 deg. 07 min. 06 sec. to the left and run a distance of 210.00 feet to a point on the South R/W line of Alabama Highway No. 70; thence turn an angle of 82 deg. 45 min. 54 sec. to the left to the tangent of said R/W curve, and continue along said R/W curve (whose Delta Angle is 06 deg. 13 min. 59 sec. to the left, Radius is 1931.32 feet, Tangent is 105.51 feet, Length of Arc is 210.10 feet) to the point of beginning; being situated in Shelby County, Alabama.
