NOTE: Mallorie Weems and Mallorie Weems Fox are one and the same person.


TO HAVE AND TO HOLD unto the said GRANTEE, his, her or their heirs and assigns, forever.

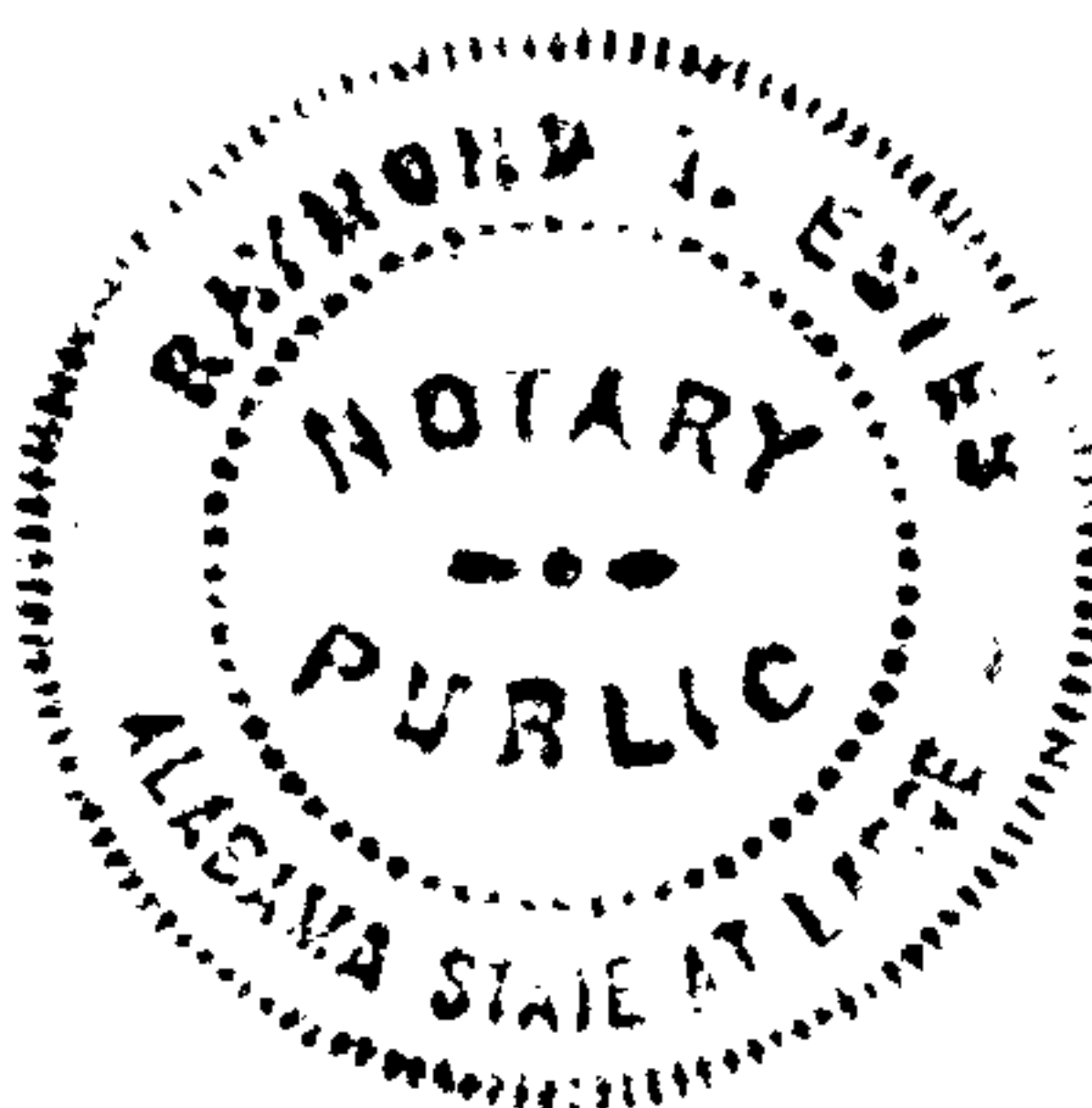
