Know All Men by These Presents: That in consideration of **One hundred fifty one thousand twenty nine and no/100 (\$151,029.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Gardner Builders, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Christopher Meadows and Lisa Meadows** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Mineral and mining rights excepted


Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.
