

SCRIVENER'S AFFIDAVIT

STATE OF ALABAMA COUNTY OF SHELBY

BEFORE ME, the undersigned Notary Public in and for said County in said State, personally appeared CARLA GRAY who is known to me and who, after being duly sworn, says as follows:

- My name is CARLA GRAY and I am the Branch Manager of American General Finance, Inc., located at 430 Green Springs Highway, Suite 13, Homewood, Jefferson County, Alabama.
- On or about the 13th day of July, 2001, American General Finance, Inc., prepared a Mortgage to be executed from Mortgagor, Charlotte D. Mahan, to Mortgagee, American General Finance, Inc. Said Mortgage was recorded as Instrument Number 2001-32606 in the Office of the Shelby County Judge of Probate. In said Mortgage an erroneous legal description was included.

COMMENCE AT THE NE CORNER OF THE NW 1/4 OF THE SW 1/4 OF SAID SECTION 27 AND RUN WEST ALONG THE NORTH LINE OF 1/4-1/4 SECTION 1105.72 FEET; THENCE LEFT 74 DEGREES 02' 15" AND RUN SOUTHWESTERLY 678.75 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE ALONG LAST COURSE 226.33 FEET TO THE NORTHERLY BOUNDARY OF SCURLOCK ROAD; THENCE LEFT 66 DEGREES 25' 10" AND RUN SOUTHEASTERLY ALONG THE BOUNDARY OF SAID ROAD 210 FEET; THENCE LEFT 113 DEGREES 34' 50" AND RUN NORTHEASTERLY LEAVING SAID ROAD 226.33 FEET; THENCE LEFT 66 DEGREES 25' 10" AND RUN NORTHWESTERLY 210.00 FEET TO THE POINT OF BEGINNING. SITUATED IN SHELBY COUNTY, ALABAMA.

Additionally, the Mortgagor should have been described as a single woman.
