WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Twenty-Seven Thousand and no/100 Dollars (\$127,000.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **MICHAEL A. BONAMY and wife, LISA BONAMY**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto, **ROBERT J. O'HARA and GAYLE E. ROGERS-O'HARA.**, (herein referred to as "Grantees"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 23, according to the Survey of Magnolia Park, St. Charles Place, Phase 3, Sector, One, as recorded in Map Book 21, Page 4, Shelby County, Alabama Records.



Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.
