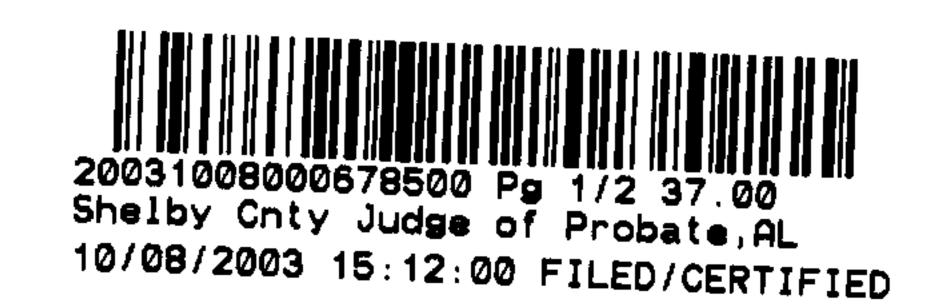

THE FOLLOWING DESCRIBED REAL PROPERTY SITUATED IN SHELBY COUNTY, ALABAMA:

COMMENCING AT AN IRON PIPE AT THE NORTHWEST CORNER OF THE NW 1/4 OF NE 1/4 OF SECTION 14, TOWNSHIP 18 SOUTH, RANGE 1 EAST AND RUN THENCE MAGNETIC SOUTH 4 DEGREES AND 16' AND EAST ALONG FENCE LINE A DISTANCE OF 1313.4 FEET TO THE SOUTHWEST CORNER OF THE SAID NW 1/4 OF SAID SECTION 14, RUN THENCE 90 DEGREES LEFT ALONG THE SOUTH LINE OF SAID FORTY ACRES 660 FEET; THENCE RUN NORTH 87 DEGREES, 27' TO THE LEFT AND ALONG THE EAST LINE OF JAMES L. BAKER PROPERTY TO THE INTERSECTION THEREOF WITH THE SOUTH RIGHT OF WAY LINE OF THE PAVES STERRETT-VANDIVER ROAD (ALABAMA HIGHWAY NO. 25) WHICH IS THE POINT OF BEGINNING OF THE PARCEL HEREIN DESCRIBED; THENCE RUN EAST ALONG THE SOUTH RIGHT OF WAY LINE OF SAID PAVES ROAD, A DISTANCE OF 200 FEET, THENCE RUN NORTH, PARALLEL WITH THE WEST DISTANCE OF 200 FEET, MORE OR LESS, TO A POINT ON THE EAST LINE OF SAID JAMES L.
