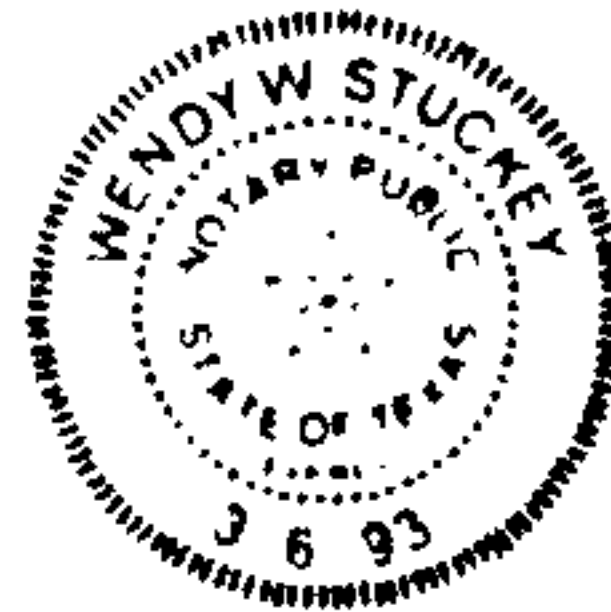


ORDER OF CHANGE OF NAME
