CERTIFICATE OF REDEMPTION

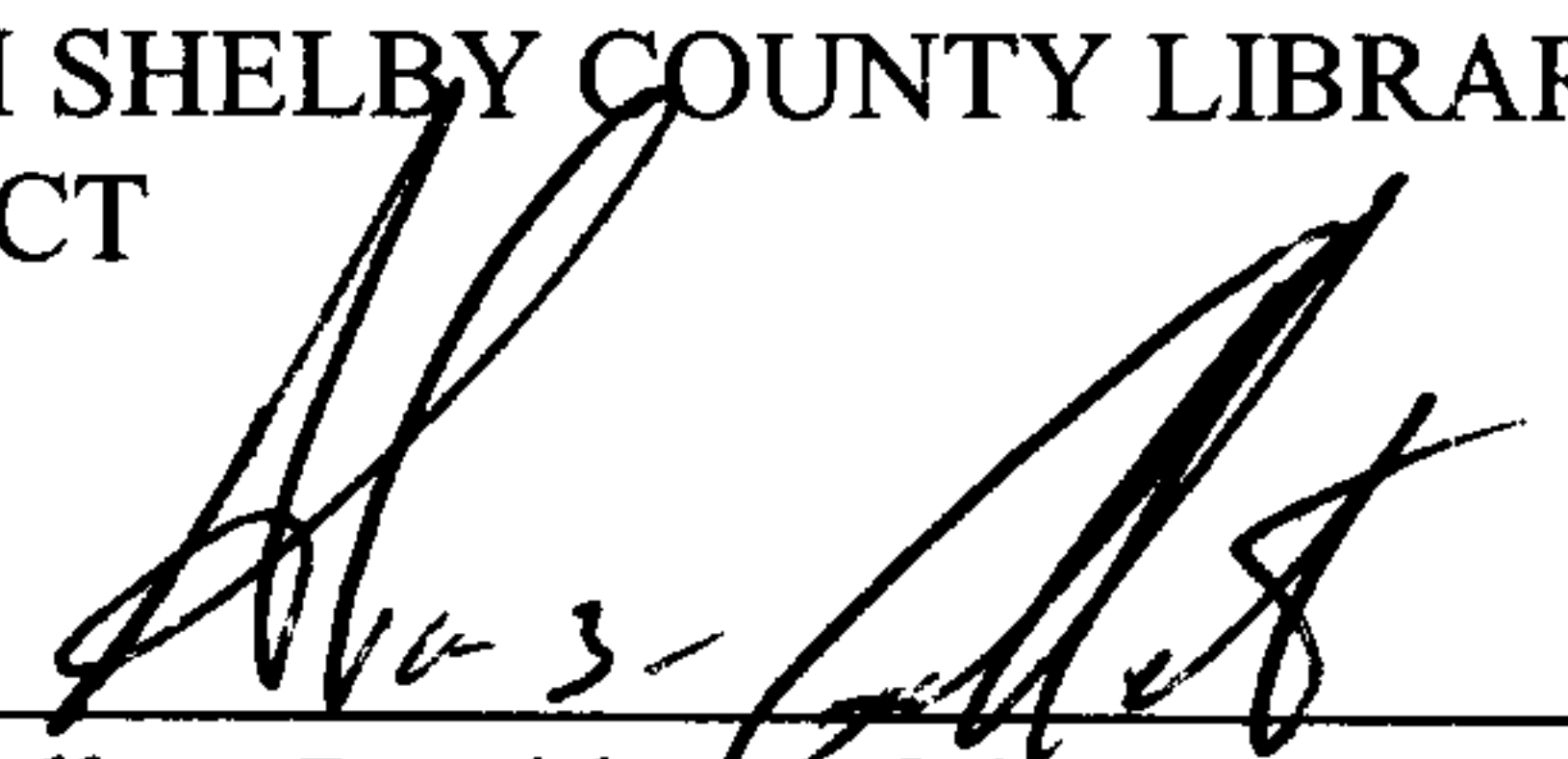
