Commence at the Southeast corner of the Southwest Quarter of the Southwest Quarter of Section 22, Township 19 South, Range 1 East for the point of beginning; thence run Northerly along the East boundary line of said ¼ - ¼ section for 420.0 feet; thence turn an angle of 90 degrees 44 minutes 29 seconds to the left and run 208.0 feet; thence turn an angle of 89 degrees 15 minutes 31 seconds to the left and run 420.0 feet to the South Boundary line of said ¼ - ¼ section; thence turn 90 degrees 44 minutes 29 seconds to the left and run along said ¼ - ¼ line for 208.0 feet to the point of beginning.
