If Borrower pays Funds to Lender, the Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a federal or state agency (including Lender if Lender is such an institution). - 11. Successors and Assigns Bound; Joint and Several Liability; Co-signers.
