

## EXHIBIT "A"

A part of the Southwest % of the Northwest % of Section 4, Township 18 South, Range 1 East more particularly described as follows: From the NW corner of said %-% section run south along west line of said %-% section a distance of 207 feet to the point of beginning; thence turn an angle to the left of 90°00′ and run in an easterly direction for a distance of 312.68 feet; thence turn an angle to the right of 26°46′ and run in a southeasterly direction a distance of 536.75 feet; thence turn an angle to the left of 69°23′ and run in a northeasterly direction a distance of 430 feet to the approximate center line of an existing road; thence turn an angle to the right of 127°08′45° and run southerly along said road a distance of 167.92 feet; thence turn to the right of 72°54′15° and run in a southwesterly direction a distance of 1217.53 feet to a point on the west line of said %-% section; thence turn an angle to the right of 112°34′ and run northerly along the said west line a distance of 585.0 feet to the point of beginning.
