Council Member Glasgow moved that Resolution No. R-2003-33 be adopted. Council Member Davis seconded said motion and upon vote, the results were as follows:

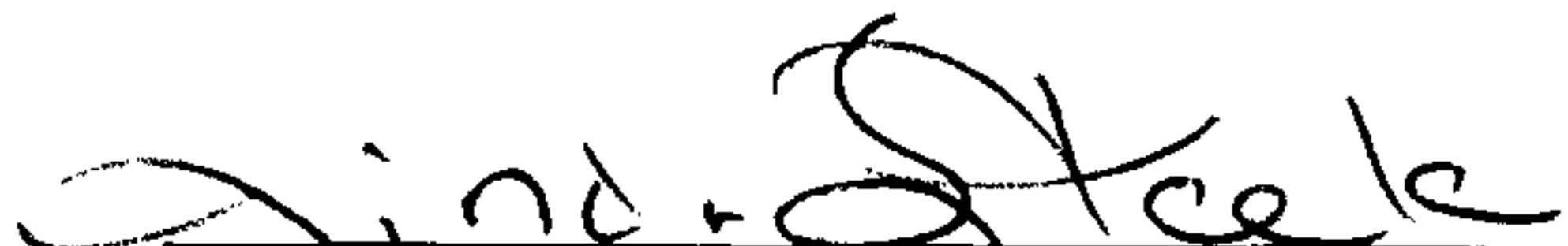
