TO-WIT:

All that portion of the North 1/2 of the Southwest Quarter of the Southeast Quarter, Section 4, Township 22 South, Range 2 West, lying North of the right of way of Shelby County Highway #84 and Southwest of the right of way Interstate 65 and West of the Highway 31 right of way.

Plaintiff alleges in said complaint that title to said lands stand upon the records of the Judge of Probate, Shelby County, Alabama, in the name of the Plaintiff and that they own in their own right a fractional interest in absolute, fee simple title to and interest in said lands, and that they acquired said lands and an absolute fee simple title, thereto, under deed executed by Walter R. Robinson, a married man, to John Albert Daugherty and Cheryl Ann Daugherty, dated November 16, 2001, recorded as Instrument #2001-50130; and under deed executed by David E. Robinson, a widower, to John Albert Daugherty and Cheryl Ann Daugherty, dated February 1, 2002, recorded as Instrument #2002-05761; and under deed executed by Charles C. Winn, a married man, to John Albert Daugherty and Cheryl Ann Daugherty, dated February 25, 2002, recorded as Instrument #2002-15820; and under deed executed by Francine L. Wynn, a single woman, to John Albert Daugherty and Cheryl Ann Daugherty, dated February 18, 2002, recorded as Instrument #2002-15822; and under deed exected by Mary Sue Lewis, a widow, to John Albert Daugherty and Cheryl Ann Daugherty, dated April 11, 2003, recorded as Instrument #20030411000222890, all in the Probate Office of Shelby County, Alabama.

Plaintiff further alleges that they are in actual and peaceable possession of said lands and that they and their predecessors in title have been in such possession for more than ten years next preceding the filing of said complaint, to-wit:

, and that no other person has been in possession of said land or any part thereof during such ten year period.

Plaintiff further alleges in said complaint that they and their predecessors in title have held color of title to said lands for a period exceeding the ten years next preceding the filing of said complaint and no other person has held color of title to said land or any part thereof during said period.

Plaintiff further alleges that they and their predecessors in title have assessed said lands for taxes and have paid taxes thereon for and during the ten years next preceding the filing of said complaint and that no other person has assessed or paid any taxes on said lands during such ten year period.

Plaintiff further alleges that after a diligent search, they have been unable to ascertain the names, ages and whereabouts of all unknown parties A, B & C.

You and each of you are hereby directed to plead, answer to said verified complaint before the 23% day of  $\sqrt{200\%}$ , or suffer a default judgment to be rendered against you.

It is therefore, ordered by the undersigned Register that publication of this notice be made in the Shelby County Reporter, a newspaper published and having a general circulation in Shelby County, Alabama, once a week for four consecutive weeks, and that all those to whom this notice is addressed and any and all persons claiming any title to, interest in, or lien or encumbrance upon, the above described real estate, or any part thereof, or any interest therein, be and they are hereby required to plead, or answer to the complaint in this cause within the time required by law, and not later than the 13 day of 100%.

It is further ordered that a copy of this notice certified by the undersigned Register, as being correct, shall be recorded as a Lis Pendens in the Office of the Judge of Probate of Shelby County, Alabama.
