

SUBORDINATION AGREEMENT

THIS AGREEMENT, made November 20, 2003, by and between Wachovia Bank of Delaware, N.A., successor by merger to First Union National Bank of Delaware, "Lienholder" and Nexstar Financial Corporation

WHEREAS, John Samuel Beeker, Jr. and Charolette L. Beeker, husband and wife, "Borrower" executed and delivered to First Union National Bank of Delaware a mortgage dated December 3, 2001, in the amount of \$160,000.00 (One Hundred Sixty Thousand and no/100ths) and interest, which mortgage was recorded January 25, 2002 as Document No. 2002-4539, in Book xxx, Page xxx, in Shelby County, State of Alabama, covering the following described property:

NOW THEREFORE, for good and valuable consideration, and in order to induce Nexstar Financial Corporation to advance funds upon its mortgage, Lienholder does hereby subordinate the lien of its mortgage to the lien of Nexstar Financial Corporation and all extensions, modifications and renewals thereof, and all advances and mandatory future advances thereunder, notwithstanding that the Lienholder's mortgage was executed and recorded prior to the execution and recordation of Nexstar Financial Corporation, and agrees that all right, title, lien and interest acquired, either by foreclosure proceedings or otherwise, under its mortgage shall be prior and superior to any and all rights, title, lien and interest heretofore and hereafter acquired by Lienholder under the Lienholder's mortgage.
