



SPECIAL POWER OF ATTORNEY

I, Lisa C. Aldridge, residing at 533 Crosscreek Trail, Pelham, Alabama 35124, hereby appoint

as my Attorney-in-Fact ("Agent").

I hereby revoke any and all special powers of attorney that previously have been signed by me.

My agent shall have full power and authority to act on my behalf, **but only to the extent permitted by this Special Power of Attorney. My Agent's powers shall be limited to the power to:**

Sell or convey any interest of mine in real estate located at:

My Agent shall not be liable for any loss that results from a judgment error that was made in good faith. However, my Agent shall be liable for willful misconduct or the failure to act in good faith while acting under the authority of this Power of Attorney.

My Agent shall provide an accounting for all funds handled and all acts performed as my Agent, if I so request or if such a request is made by any authorized personal representative or fiduciary acting on my behalf.
