(“Moore-Handley”) filed in this Court its petition requesting that this Court certify to Lien Claimant, Centimark Corporation, that its lien claim, recorded as Instrument Number 20030710000436260 in this Court, has been transferred from the real property upon which the lien was sought to be imposed to the bond in the amount of \$53,343.72. filed with this Court by the Petitioner, pursuant to § 35-11-233 of the Code of Alabama, 1975.

It appears to the Court, and is so ordered, that the bond in the sum of \$80,015.58 issued by Platte River Insurance Co. has been deposited with this Court and that the lien claim is hereby transferred from the real property to the bond.

NOW THEREFORE, the Court does hereby accordingly certify to Centimark Corporation, Respondent herein, that the bond has been filed by the Petitioner and that the Court

has accordingly transferred said lien claim from said real estate property to the said bond, that the said Centimark Corporation, shall have ten days from the receipt of this certificate to petition this Court for a hearing on the sufficiency of the amount in question or on the qualifications of the surety insurer.

The Clerk of this Court is hereby ordered to (1) send, by certified mail, a copy of this certificate, together with a copy of the petition filed by Moore-Handley, to Centimark Corporation at the address shown in the petition, and (2) record a copy of this certificate in the recording division of this Court.


