IN VALUABLE CONSIDERATION OF TEN DOLLARS (\$10.00), and other good and valuable consideration, cash in hand paid, the receipt and sufficiency of which is hereby acknowledged, Boyce L. Trott, Sr., hereinafter referred to as the "Grantor", does hereby remise, release, quitclaim, grant and convey unto Boyce L. Trott Sr., Irrevocable Trust, hereinafter referred to as "Grantee", the following lands and property, together with all improvements located thereon in the county of Shelby County, State of Alabama, to wit:

Begin at a point where the Western Boundary of the SW ¼ of the SE ¼ of Section 9, Township 24 North, Range 14 East is intersected by the North Boundary line of the Hiwassee Dirt Road; thence run North along the Western Boundary of said ¼ - ¼ Section a distance of 228 feet, more or less, to the Northwest Corner of said ¼ - ¼ Section; thence run due East along the Northern Boundary of said ¼ - ¼ Section 150 feet, more or less, to the point of intersection of the Northern Boundary of said ¼ - ¼ Section with the Western Bank of Buxahatchee Creek; thence turn to the right and run in a Southerly and Southwesterly direction along the low water edge of Buxahatchee Creek 228 feet, more or less, to a point where the same intersects the North Boundary line of the Hiwassee Dirt Road; thence turn right and run 200 feet, more or less, along the Northern Boundary of the Hiwassee Dirt Road to the point of beginning.
