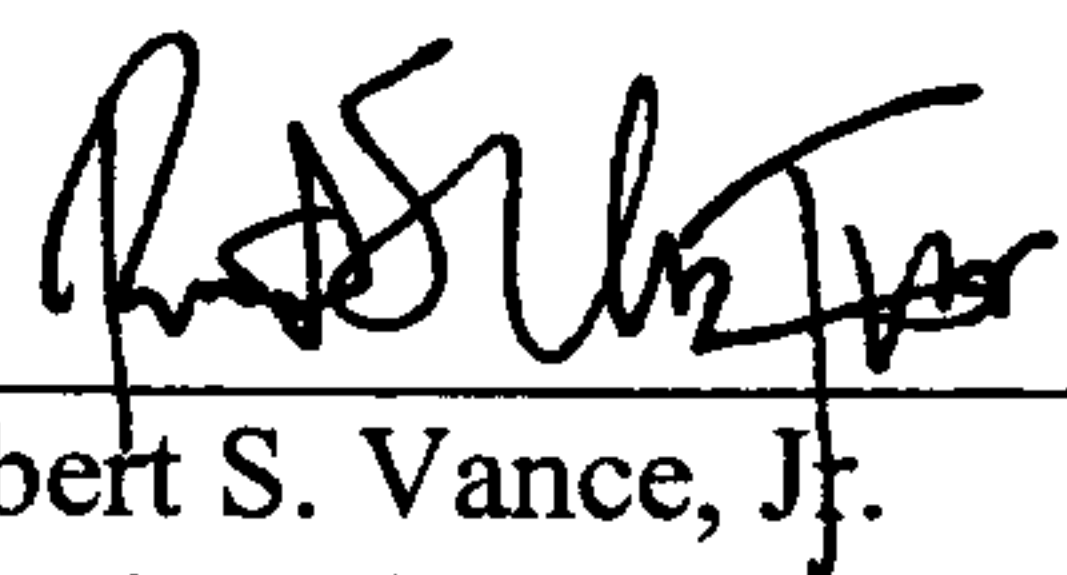
ORDER

Pending is the plaintiff's application for default judgment. The defendant has failed to answer or otherwise appear despite having been served with process on June 30, 2003. Accordingly, **default** is entered against the defendant.

From the materials filed in support of the plaintiff's application, it further appears that the defendant is indebted to the plaintiff in the principal amount of \$27,434.86, plus attorney's fees. The Court hereby finds that \$5,486.97, which constitutes 20% of the principal indebtedness, is a reasonable attorney's fee.

Accordingly, **JUDGMENT** in the amount of \$32,921.83 is hereby entered in favor of the plaintiff and against the defendant, for which execution may issue. Costs taxed to the defendant.
