THIRD AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS FOR SHIRE VALLEY FARMS

KNOW ALL MEN BY THESE PRESENTS; that

Heretofore, the Declaration of Restrictive Covenants for Shire Valley Farms was filed in Instrument 20030516000307910 in the Office of the Judge of Probate of Shelby County, Alabama (the Declaration) which Declaration was amended by First Amendment to Declaration of Restrictive Covenants for Shire Valley Farms recorded in Instrument 20030929000652340 in the Office of the Judge of Probate of Shelby County, Alabama (the First Amendment) and further amended by Second Amendment to Declaration of Restrictive Covenants for Shire Valley Farms recorded in Instrument 20030929000652350 in the Office of the Judge of Probate of Shelby County, Alabama (the Second Amendment). Herein, the Declaration, the First Amendment and the Second Amendment are collectively referred to as the Covenants; and

Whereas, the undersigned being the Developer, all Owners and the Mortgagee of Tracts or Lots (as those terms are defined in the Covenants) hereby adopt this Third Amendment to Declaration of Restrictive Covenants for Shire Valley Farms.

The Covenants are hereby amended to provide as follows:

- 1. To Article III of the Declaration is hereby added additional paragraph(p) which states as follows:
- (p)UTILITIES. All utilities, including, without limitation, electrical power, serving each Lot and the Primary Dwelling and Outbuildings thereon shall be run underground from the main utility source on the Road (Shire Valley Road) and any easement or road accessing the Lots from a public road. At the discretion of the Developer, the main power source running down the Road may be overhead power.
- 2. All capitalized terms contained in this Third Amendment shall have the same meaning as those set forth in the Covenants.
- 3. Unless specifically modified by this Third Amendment, the provisions of the Covenants shall remain in full force and effect.
