SPECIAL WARRANTY DEED

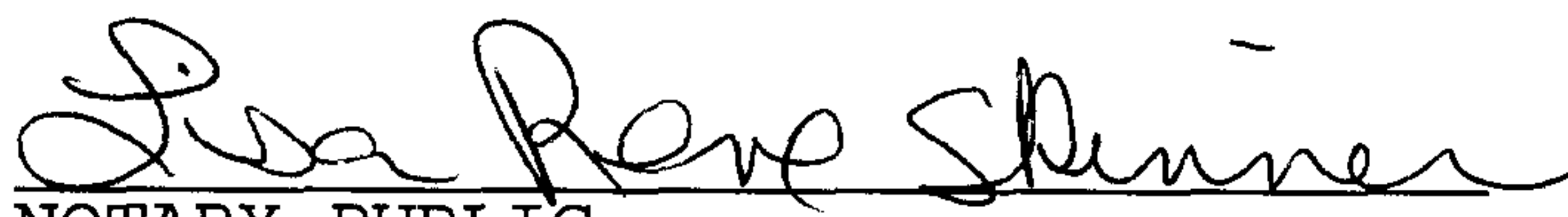
