ORDER

THIS CAUSE was heard on October 27, 2003 on Plaintiff's Motion for Summary Judgment. Upon consideration of the Motion the Affidavit of the Plaintiffs, David A. Argent and Heather Z. Argent, and the Affidavit of Counsel for the Plaintiffs, William H. McGowen III, as well as the evidence presented at the hearing, the Court orders that a judgment is hereby entered in favor of the Plaintiffs, David A. Argent and Heather Z. Argent, and against the Defendant, MURFCO Investments, LLC d/b/a Build America Homes, an Alabama Limited Liability Company, a/k/a Build America Homes, L.L.C., a Limited Liability Company as follows:

With regard to Plaintiff's Count Four of the Alias and Amended Verified Complaint, "Complaint to Quiet Title of Land", judgment is hereby awarded in favor of the Plaintiffs as follows:

is hereby terminated pursuant to Code of Alabama, Section 6-6-540 and Section 6-6-543, and that the Defendant has no interest in the property described. The Court has considered that the Defendant has failed to set out and specify, as required in Code of Alabama, Section 6-6-541, its title, claim, interest, or encumbrance and how and by what instrument the same is derived and created. Title in said property is hereby quieted in favor of the Plaintiffs in said property subject to any valid liens or encumbrances from other parties not subject to this cause.

Pursuant to Rule 54(b) of the Alabama Rules of Civil Procedure, it is hereby expressly ordered and directed that there be an immediate entry of judgment as the Court has determined that there is no just reason for delay.

The remaining claims included in the various remaining Counts of the Alias and Amended Verified Complaint are not made a part of this Order and this Order shall not terminate those claims or the rights and liabilities of the parties.

It is also hereby ordered and required that the judgment certificate be recorded in the Office of the Judge of Probate indicating that the Defendant, Build America Homes, L.L.C. be indexed as the Grantor of all of its real estate interest in the property specifically described above and that the Plaintiffs, David A. Argent and Wife, Heather Z. Argent be indexed as the Grantees of the said real estate interest,
