

For-Profit Corporation Articles of Incorporation

Instructions:

Step 1: Contact the Office of the Secretary of State at (334)242-5324 to reserve a corporate name.

Step 2: To incorporate, file the original, two copies of the Articles of Incorporation and the certificate of name reservation in the county where the corporation's registered office is located. The Judge Probate's filing fee is \$35 and the Secretary of State's filing fee is \$50.

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following articles of incorporation.

Article I	The name of the corporation: Computer Systems Management Corporation of Alabama Inc.
Article II	The duration of the corporation is perpetual, unless otherwise stated.
Article III	The corporation has been organized for the following purpose(s): Primarily engaged in supplying computer-related services, operating on a contract or fee basis. See SIC Code 7379.
Article IV	The number of shares which the corporation shall have the authority to issue is 2000 .
Article V	The street address (NO PO BOX) of the registered office <u>521 Wynlake</u> <u>Court, Montevallo, Alabama 35115</u> . Located in the County of <u>Shelby</u> and the name of the registered agent at that office <u>Hugh Martin</u> .
Article VI	The name(s) and address(es) of the Director(s). Hugh Martin, 521 Wynlake Court Montevallo, Alabama 35115
Article VII	The name(s) and address(es) of the Incorporator(s). <u>Business Filings</u> <u>Incorporated, Mark Schiff, AVP, 8025 Excelsior Drive, Suite 200, Madison, WI 53717.</u>

Any provision, not inconsistent with the law, for the regulation of the internal affairs of the corporation or for the restriction of the transfer of shares may be added.
