

## ARTICLES OF DISSOLUTION OF THE DORIS M. SCHULER FOUNDATION

- 3. All debts, obligations, and liabilities of the corporation have been paid and discharged or adequate provision has been made therefor.
  - 4. The corporation did not adopt a plan of distribution.
- 5. All remaining property and assets of the corporation have been transferred, conveyed, or distributed in accordance with the provisions of the Act.
  - 6. There are no suits pending against the corporation in any court.
