

ARTICLES OF INCORPORATION

OF

Pedersen Corporation An Alabama Corporation

(Pursuant to the provisions of the Alabama Business Corporation Act)

The undersigned person has associated themselves for the purpose of forming a corporation under the laws of Alabama and adopts the following Articles of Incorporation.

- 1. Name. The name of this corporation is Pedersen Corporation. The period of duration shall be perpetual.
- 2. <u>Purpose and Powers.</u> The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the laws of Alabama other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Alabama Statutes.

This corporation shall have the broad general powers set forth in the Alabama Statutes, and in addition the following powers:
