
This property does not consitute any part of homestead for grantor or spouse.

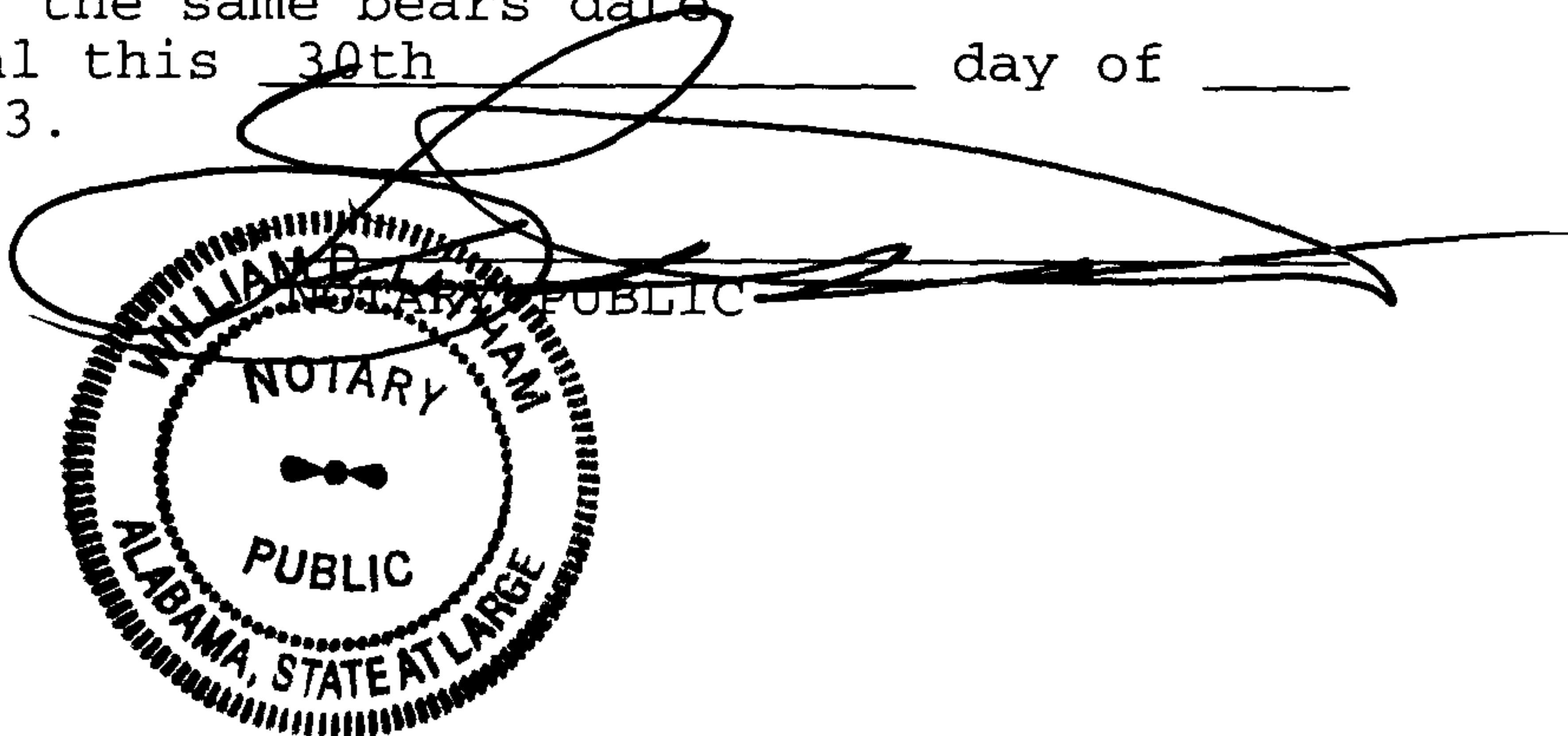

SCHEDULE A

PROPERTY DESCRIPTION:

State of Alabama

Shelby County

A parcel of land in the SE 1/4 of the NE 1/4 of Section 3, Township 24 North, Range 12 East, Shelby County, Alabama, more particularly described as follows:

From the SW Corner of said 1/4 - 1/4 Section run North along the West Boundary thereof for a distance of 127.91 feet to the point of beginning of the property herein described; thence continue on the same course for a distance of 520.54 feet to the Southwest right of way line of Alabama Highway No. 25; thence turn an angle to the right of 97 degrees 42 minutes and 53 seconds and run in a Southeasterly direction along said right of way line for a distance of 150.0 feet; thence turn an angle to the right of 82 degrees 07 minutes 46 seconds and run South for a distance of 500.00 feet; thence turn an angle to the right of 90 degrees and run West for a distance of 150.00 feet to the point of beginning of the property herein described, containing 1.749 acres, more or less.
