SPECIFIC POWER OF ATTORNEY

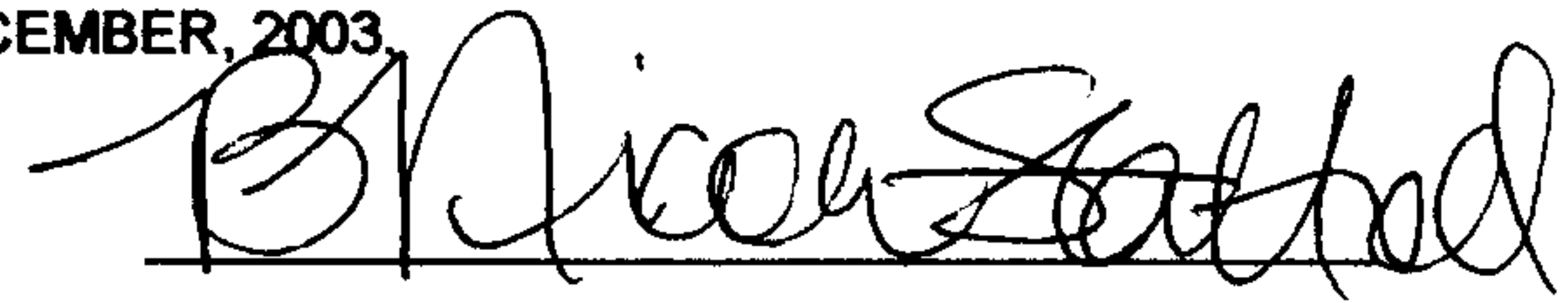
