KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of <u>Sixty-One Thousand & 00/100 Dollars</u> (\$61,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, <u>Lorraine P. Byrd</u>, a <u>single person</u>, hereinafter called "Grantors", do hereby GRANT, BARGAIN, SELL AND CONVEY unto <u>Julian Broadhead</u>, and <u>Brandon A</u>. <u>Broadhead</u>, <u>single persons</u>, hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County**, **Alabama**, to wit:

Lot 6,in Block N, according to the Lyman's Addition to the Town of Montevallo, as recorded in Map Book 3, Page 27, in the Probate Office of Shelby County, Alabama.

Subject to all items of record.

NOTE: Lorraine P. Byrd and Lorraine Pearce Byrd are one and the same person.
