TWELFTH AMENDMENT TO CERTIFICATE AND LIMITED PARTNERSHIP AGREEMENT


- 1. The name of the Partnership is Chelsea Farm Partnership, Ltd.
- 2. The Certificate was filed on August 5, 1993 in the office of the Judge of Probate of Shelby County, Alabama as instrument 1993-23134.
- 3. On January 1, 2004, Laurence D. Weygand transferred a one percent (1%) limited partnership interest in the Partnership to each of Stacy Weygand Barnett, Christopher B. Barnett, Scott Laurence Weygand, Louis Raymond Weygand and Michelle K. Weygand.
- 4. The Certificate is hereby amended by deleting Section 2.02 thereof in its entirety and substituting in lieu thereof the following as new Section 2.02:
