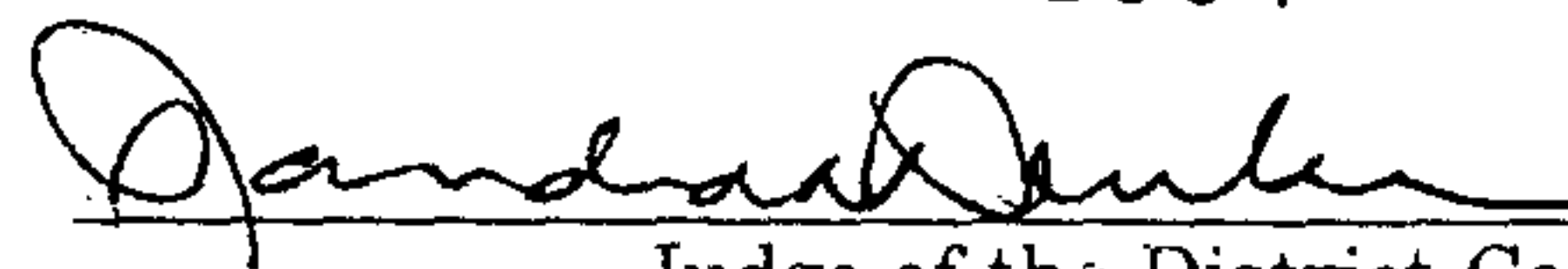

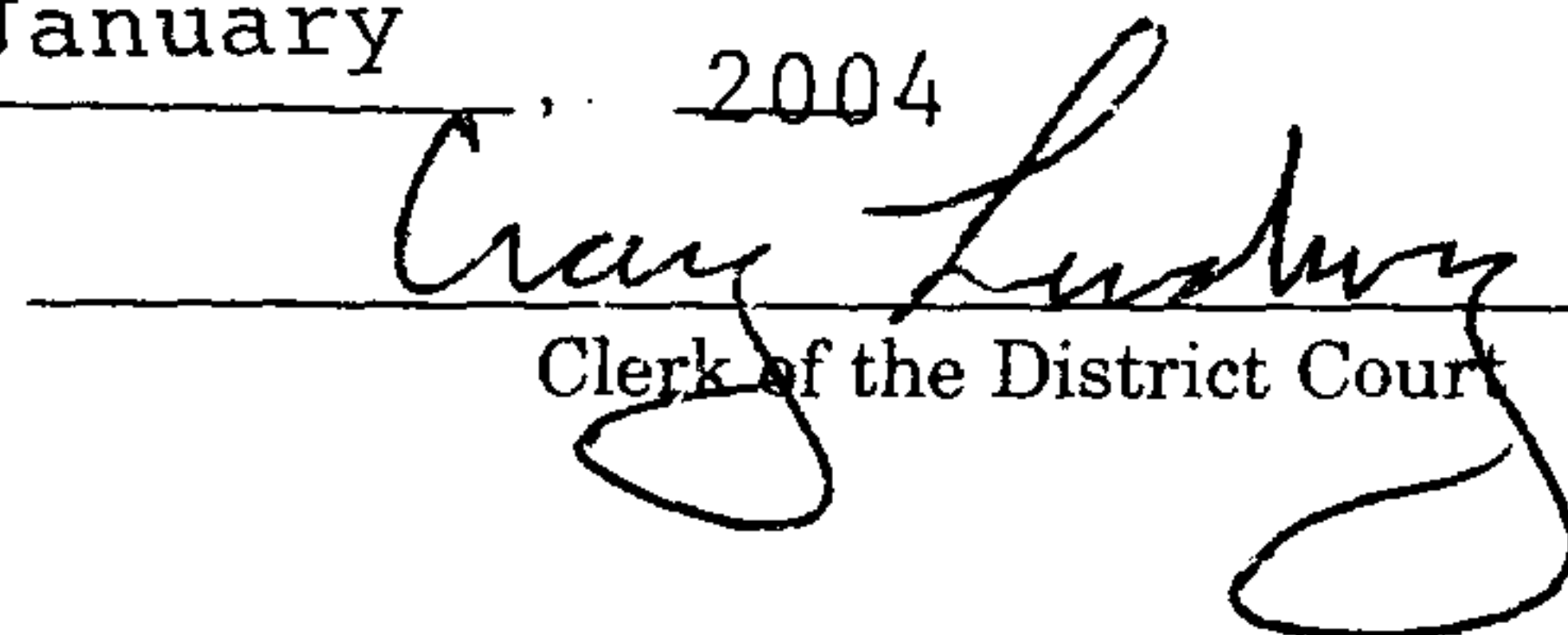

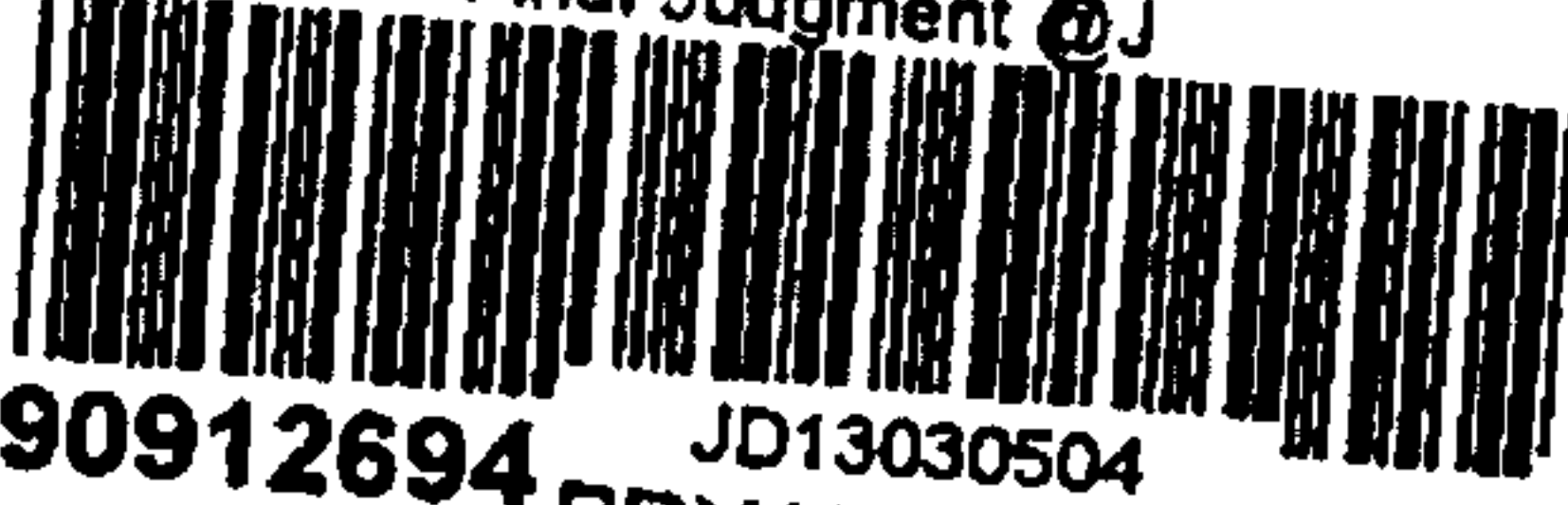

Based on the Order Granting Summary Judgment, the Court awards final judgment in favor of the Plaintiff Cura Capital Corporation and against the Defendant R. Don Bryan, awarding the following:

1. Damages in the total amount of \$208,026.40.
2. Costs in the amount of \$ 120⁰⁰.
3. Attorneys fees in the amount of \$ 9,201⁵⁰.

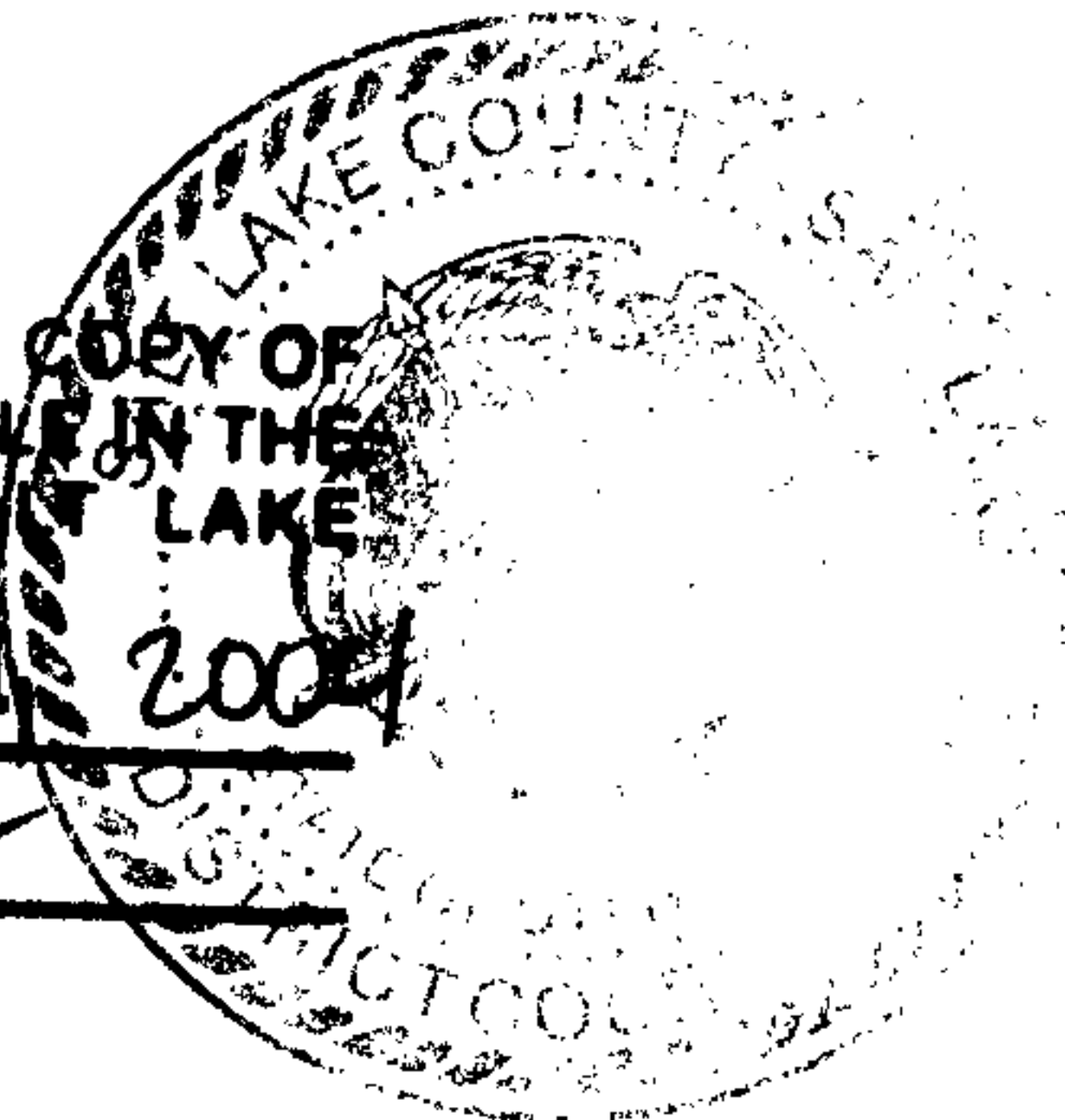
