## DOMESTIC LIMITED LIABILITY COMPANY ARTICLES OF ORGANIZATION GUIDELINES

### INSTRUCTIONS:

**STEP 1: THE NAME OF THE LIMITED LIABILITY COMPANY MUST CONTAIN THE WORDS LIMITED LIABILITY COMPANY, LLC OR L.L.C.**

**STEP 2: FILE THE ORIGINAL AND TWO COPIES OF THE ARTICLES OF ORGANIZATION IN THE COUNTY WHERE THE LLC'S REGISTERED OFFICE IS LOCATED. THE SECRETARY OF STATE'S FILING FEE IS \$40. PLEASE CONTACT THE JUDGE OF PROBATE TO VERIFY THE PROBATE FILING FEE.**

**PURSUANT TO THE ALABAMA LIMITED LIABILITY COMPANY ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF ORGANIZATION.**


- Article I*      The name of the Limited Liability Company:  
Bishop Martin, LLC  
(Your company title must end with the words Limited Liability Company, L.L.C. or LLC)
- Article II*      The duration of the Limited Liability Company is until December 31, 2040.
- Article III*      The Limited Liability Company has been organized for the following purpose(s):  
purchasing or otherwise acquiring, owning, financing, holding, managing, selling, exchanging, leasing, maintaining, constructing, developing, or otherwise dealing with and disposing of real property and related assets and properties and for the further purpose of transacting any and all lawful business for which limited liability companies may be formed under the Alabama Limited Liability Company Act, as from time to time may be amended. The limited liability company shall have all of the powers as set forth in Section 10-12-4, Code of Alabama, 1975, as amended from time to time, and such other powers as may be granted to limited liability companies in the State of Alabama or such other jurisdictions as the Company may be doing business from time to time. To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.
- Article IV*      The **street address** (NO PO BOX) of the registered office: 1960 Hwy 33, Ste D, Pelham, Alabama 35124 and the name of the registered agent at that office: James E. Bishop
- Article V*      The **names and addresses** of the initial member(s), and organizer (if any):

- Article VI*      If the Limited Liability Company is to be managed by one or more managers, list the names and addresses of the managers who are to serve until the first annual meeting of the members or until their successors are elected and qualified.
