

WARRANTY DEED Joint tenants with right of survivorship

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred, Fifty Eight Thousand, Nine Hundred and no/100's Dollars (\$158,900.00) and other good and valuable consideration to the undersigned grantors, CRAIG ALAN ANDREWS and wife, KIMBERLY ANDREWS in hand paid by the grantees herein, the receipt whereof is hereby acknowledged the said grantors do grant, bargain, sell and convey unto MOLLY G. WARING and WILLIAM H. WARING, III, the following described real estate situated in Shelby County, Alabama, to-wit:
