## PETITION FOR ANNEXATION TO THE CITY OF HELENA, ALABAMA

Date of Petition: December 1, 2003

To the Honorable Mayor and City Council of the City of Helena, Alabama:

The undersigned, UNITED STATES STEEL CORPORATION, a Delaware corporation, successor (by conversion) to United States Steel LLC and remote successor to USX Corporation (herein called the "Petitioner"), hereby petitions and requests that the City of Helena, Alabama (herein called the "City"), annex the real property described on EXHIBIT "A" and shown on map marked EXHIBIT "B" attached hereto and made a part hereof (such real property being herein called the "Property"). In support of such petition and request, the Petitioner hereby makes the following recitals:

- The Property consists entirely of real property owned by the Petitioner; or, in other words, the only owner of any of the Property is the Petitioner.
- The Property is contiguous to the existing corporate limits of the City and is situated wholly within the boundaries of Shelby County, Alabama; but no part of the Property is located within the existing corporate limits of either the City or any other municipality.

This Petition is conditioned upon the following:

(1) Continuation of natural resources development, extraction, collection, and transportation activities, including, without limitation, the installation, use, and operation of gas wells and pipelines in the area South of Beaver Dam Creek.

The Petitioner also requests that the Honorable Mayor and City Council of the City do all things necessary and requisite under the laws of the State of Alabama in connection with the annexation hereby requested.

The relationship of the Property to the corporate limits of the City is shown on EXHIBIT "B".

# LEGAL DESCRIPTION HELENA ANNEXATION

A tract of land situated in Sections 30, 31, and 32 of Township 20 South, Range 3 West of the Huntsville Principal Meridian, Shelby County, Alabama, and being more particularly described as follows.

#### SECTION 30, TOWNSHIP 20 SOUTH, RANGE 3 WEST

The SE-1/4 of NE-1/4; the E-1/2 of SE-1/4; and the SW-1/4 of SE-1/4.

### SECTION 31, TOWNSHIP 20 SOUTH, RANGE 3 WEST

The N-1/2 of NE-1/4, and the NE-1/4 of NW-1/4.

A tract of land situated in the S-1/2 of the N-1/2 described as follows:


**BEGINNING** at the NE corner of the S-1/2 of N-1/2 of Section 31; run southerly along the east line of said S-1/2, 245.0 feet, more or less, to the NW corner of a tract of land owned by Nancy Carolyn Minshew; thence right 90°-00′-00″, more or less, and run westerly and parallel to the south line of the N-1/2 of the N-1/2 of said Section 31 to a point on the west line of the SE-1/4 of NW-1/4 of Section 31; thence right 90°-00′-00″, more or less, and run northerly along said west line 25.0 feet, more or less, to a point on the south line of last said N-1/2 of N-1/2; thence right 90°-00′-00″, more or less, and run easterly along said south line of the N-1/2 of N-1/2 to the **POINT OF BEGINNING**.
