Subject to restrictions, easements and rights of way of record.

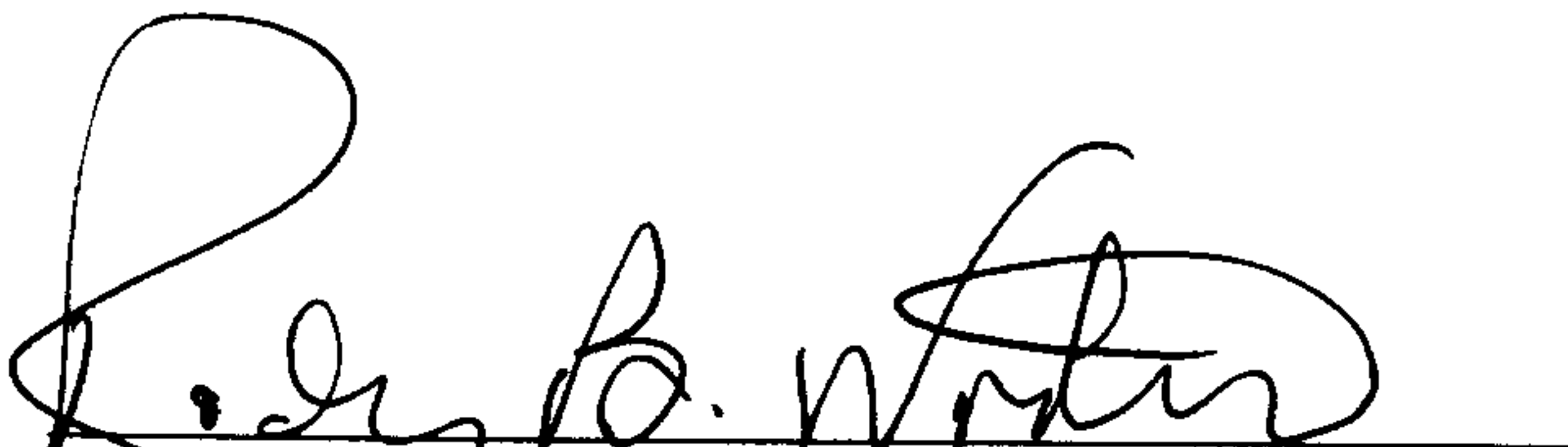

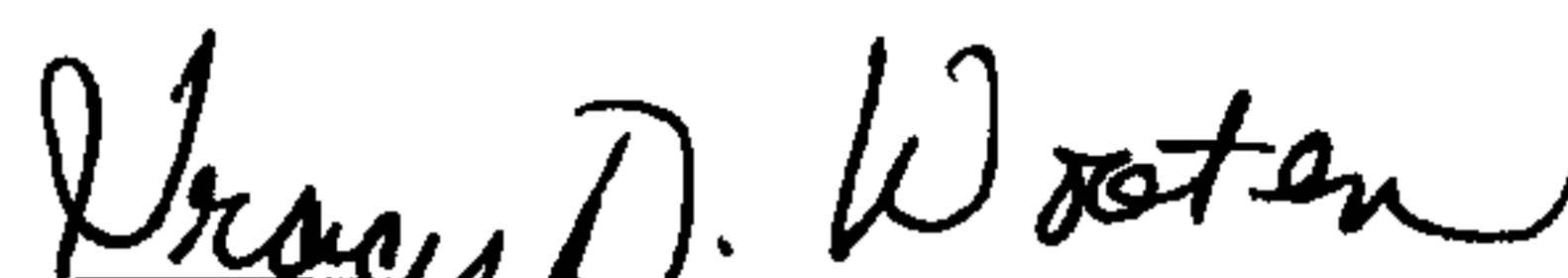
\$163,850.00 of the above-recited consideration was paid from a mortgage recorded simultaneously herewith.

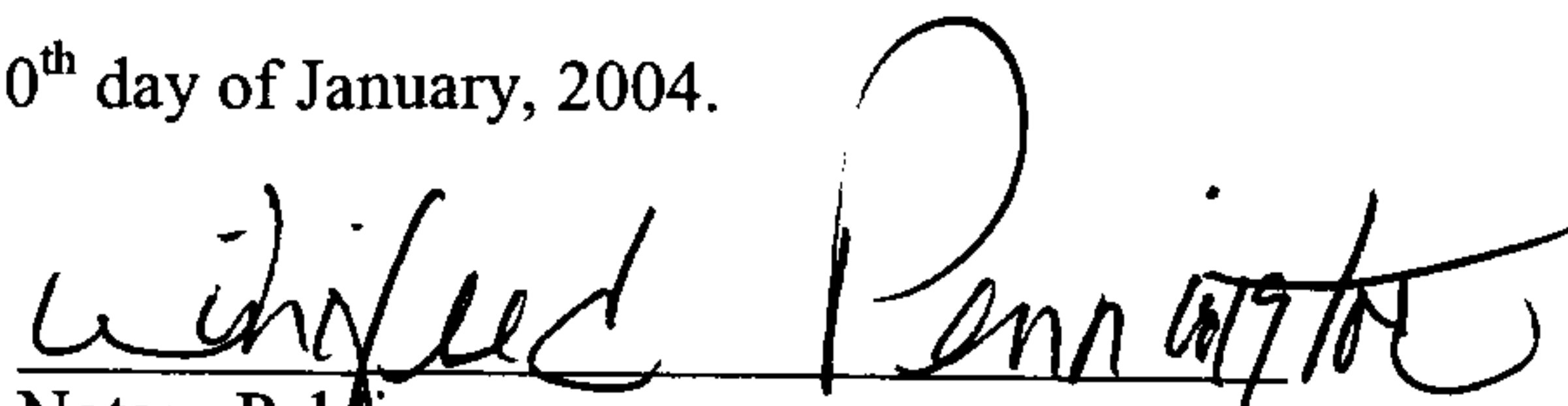
