KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Ten Thousand and no/100 Dollars (\$210,000.00 ) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, VICTOR J. GAJEWSKI and wife, BARBARA M. GAJEWSKI, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto, DONALD R. HOWARD and JACQUELINE P. HOWARD, (herein referred to as "Grantees"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in Shelby County, Alabama, to wit:

Lot 187, according to the Survey of Wynlake Subdivision, Phase 4-A, as recorded in Map Book 22, Page 19, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.


Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.


\$199,500.00 of the purchase price was paid from the proceeds of a mortgage loan closed simultaneously herewith.

IN WITNESS WHEREOF, the Grantor has signed and sealed this Deed on the 2<sup>nd</sup> day of February, 2004.


