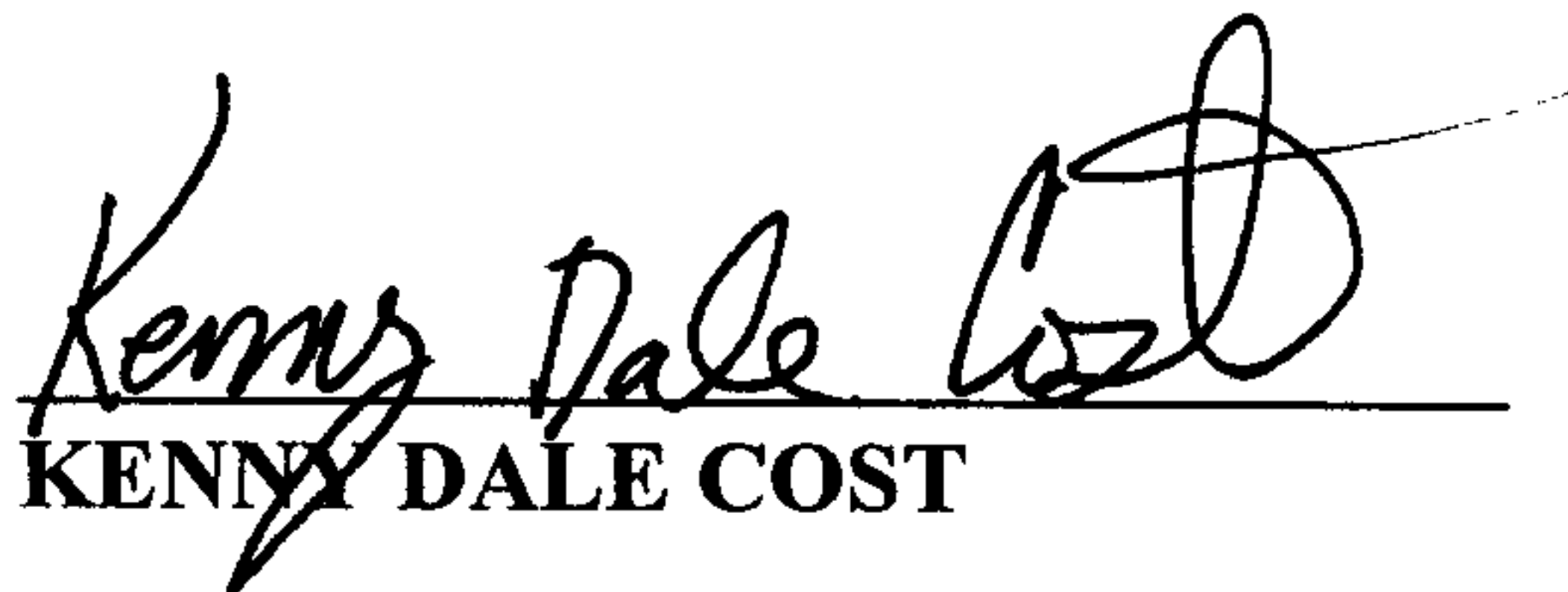
ARTICLE NINE

ARTICLE TEN

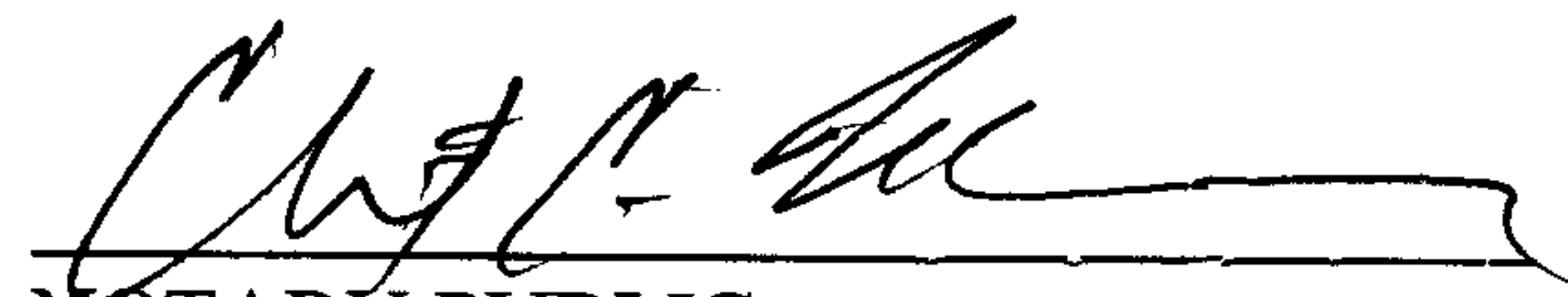
