WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Hundred Twenty-Seven Thousand and NO/100 (\$127,000.00) Dollars and other good and valuable consideration to the undersigned, **Denson E. Hulsey, Jr and Deborah S. Hulsey, husband and wife**, herein referred to as Grantor, in hand paid by **Victor M. Garcia**, a married man, herein referred to as Grantee, the receipt of which is acknowledged, the said Grantor does hereby grant, bargain, sell and convey unto the Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 2, Block 1, according to the Survey of Brookfield First Sector, as recorded in Map Book 5, Page 125, in the Office of the Judge of Probate of Shelby County, AL. Mineral and Mining Rights Excepted.
