THIS DEED IS BEING RE-RECORDED TO CORRECT THE GRANTEE WIFE NAME. A SECOND TIME.

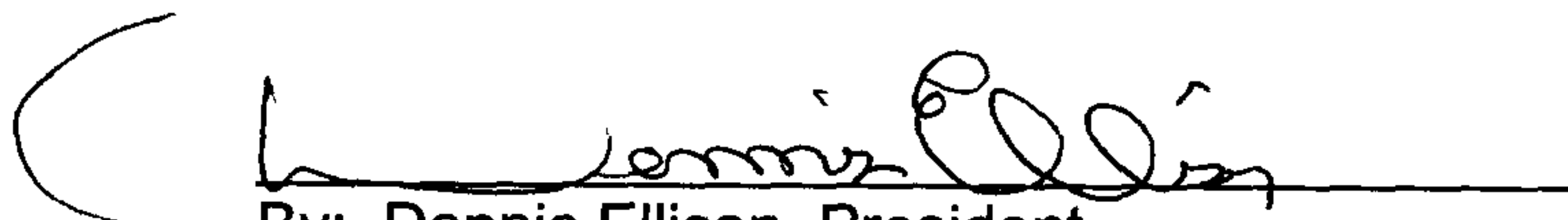
Professional Homebuilders, Inc. and Professional Home Builders, Inc. are one and the same entity.
