JOSEPH F. CHAMPION III, AND TRACY B. CHAMPION, HUSBAND AND WIFE

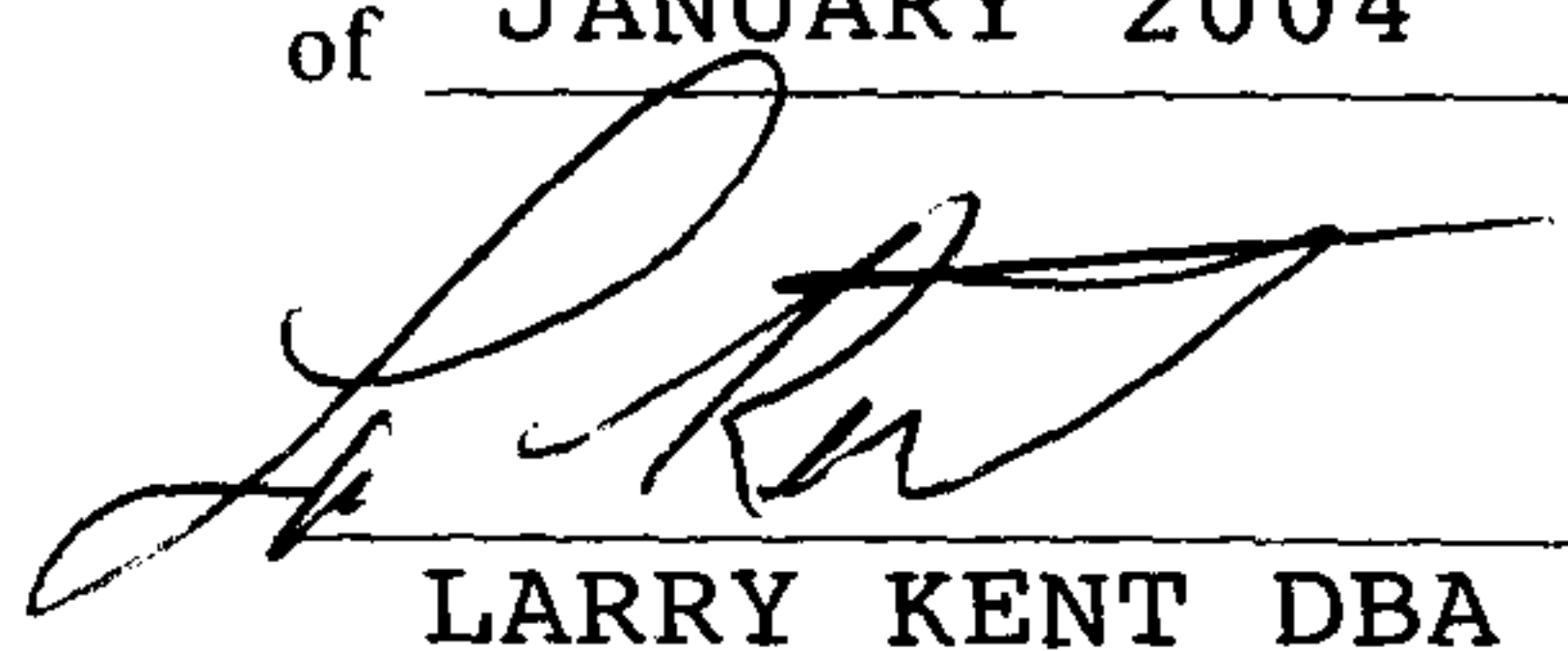
(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate

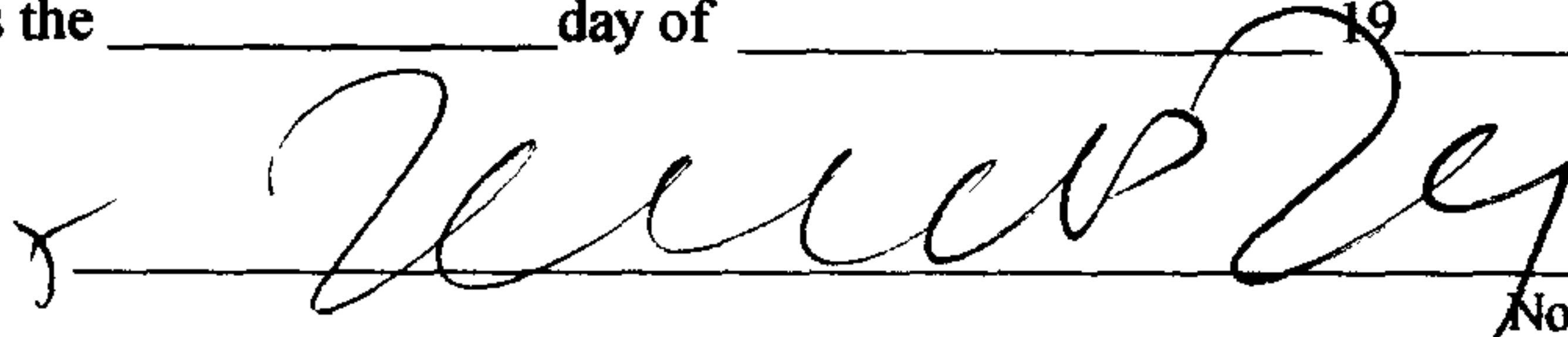

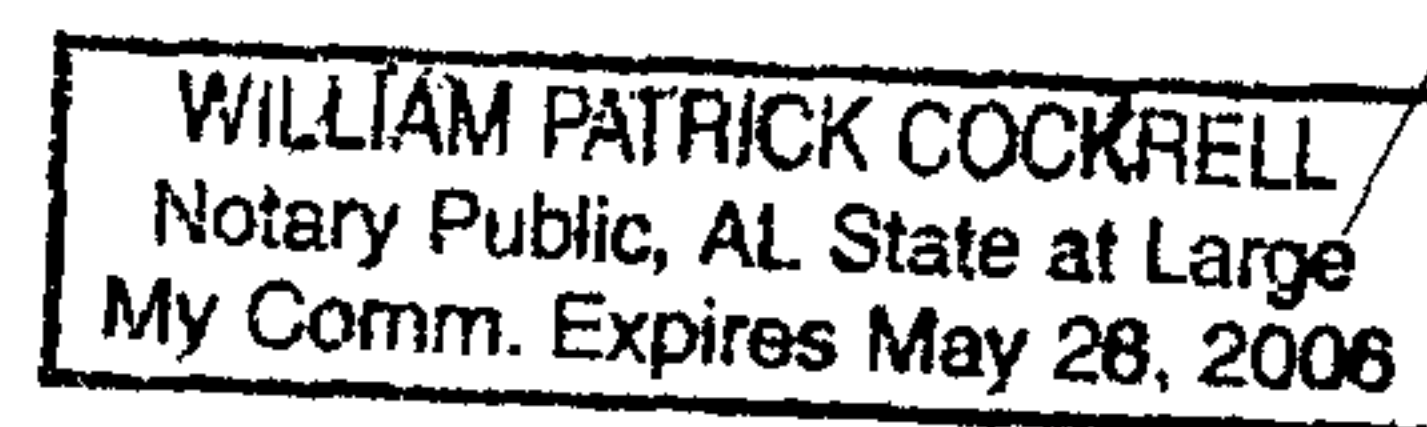
