WARRANTY DEED JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

to the undersigned grantor, or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged,
we, LARRY KENT DBA LARRY KENTY HOMEBUILDERS, A CORPORATION
(herein referred to as grantors) do, grant, bargain, sell and convey unto JOSEPH F. CHAMPION III, AND TRACY B. CHAMPION, HUSBAND AND WIFE
(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in SHELBY County, Alabama, to-wit:
LOT 121, ACCORDING TO THE SURVEY OF FOREST PARKS 1ST SECTGOR AS RECORDED IN MAP BOOK 22, PAGE 28, IN THE PROBATE OFFICE OF SHELBY COUNTY ALABAMA.
