PARTIAL RELEASE

WHEREAS, by instrument dated August 11, 1941 and recorded in Book 112, Page 281 of the official records of the Office of the Judge of Probate of Shelby County, Alabama, Plantation Pipe Line Company was conveyed a right-of-way and easement to construct, maintain, operate, alter, repair, remove, change the size of, and replace pipelines and appurtenances thereto for the transportation of oil, crude petroleum and refined petroleum products or combinations thereof or similar thereto, natural and artificial gas, casinghead and natural gasoline and any other liquids or gases under, upon, over and through the following-described lands situated in the County of Shelby and State of Alabama to-wit:

All of the W½ of the SW¼ lying SW of Buck Creek, Section 11, Township 21 South, Range 3 West.

WHEREAS, it has been requested that said right-of-way and easement be released and quitclaimed except as to the portion needed in connection with the existing pipelines.

NOW THEREFORE, for and in consideration of One Dollar and other good and valuable consideration, receipt of which is hereby acknowledged, Plantation Pipe Line Company, a Delaware and Virginia corporation, does hereby release and quitclaim unto the current owners of record, their heirs and assigns, all of its right, title and interest acquired under the aforesaid right-ofway grant, to the following-described land:

Except as herein modified, the right-of-way and easement granted by instrument dated August 11, 1941 shall remain in full force and effect including the right to install additional pipelines.
